I am aware that the event is not a sports event as defined by the Deutscher Motorsportbund (DMSB) and that for this reason a sports event liability insurance does not exist. The purpose of the event is to achieve driving safety, driving discipline and accident prevention, but not to achieve maximum speeds of the respective vehicle. I am aware that the conduct of private races with other participants during the event is prohibited. I will refrain from encouraging the respective driver of the vehicle to achieve maximum speeds or to race in private competitions with others.

**Participation in the event is at your own risk!**

I am aware that test and set-up sessions can also cause physical damage to health. I hereby confirm that I do not suffer from cardiovascular problems or vertebral problems. For the purpose of self-protection, I undertake toward the organiser to wear safety overalls with at least single-layer fire-protection fabric and helmet. I am aware that driver and organiser have concluded a comprehensive liability exclusion with the exception of bodily injury and deliberate or grossly negligent breach of duty on the part of the organiser. Being fully aware of this exclusion of liability submitted by the driver, I also declare with the submission of this document that I waive all claims or rights to pursue action for damages in connection with the event against:

- The Nürburgring 1927 GmbH & Co. KG (NG 27) as the lessee of the estate, the structural facilities and equipment as well as the operator of the circuit and its vicarious agents
- the organiser of the VLN VV GmbH & Co.KG, their agents and other persons employed to perform an obligation and volunteers;
- the agencies responsible for the construction and maintenance of the roads, insofar as damages are caused by the conditions of the roads and tracks, including other installations, that are used for the event
- other agents and other persons employed to perform an obligation within the organisation of the event.

I undertake to follow at all times any instructions of the organiser, of its agents and other persons employed to perform an obligation and/or of any other person involved in the organisation. I undertake furthermore to wear the armband issued by the organiser clearly visible throughout the entire duration of the event and to present it upon request. I am aware that I as well as the driver may be disqualified from the event and thus from any other rides in the case of the removal of the armband.

I am aware that in particular vehicles that are not registered for public traffic are allowed to take part in the event. Participants undertake to inform each other comprehensively about any possible dangers involved in the participation.
