I am aware that the event is not a sports event in the sense of the German Motorsport Federation (DMSB) and for this reason a sports event liability insurance does not exist. The event serves to achieve driving safety, driving discipline and accident prevention, but not to achieve the maximum speed of the respective vehicle. I am aware that private racing during the event with other participants is prohibited. I will refrain from encouraging the respective driver of the vehicle to achieve the maximum speed or to organize private races.

### Participation at the event is at your own risk!

I am aware that test and setting drives can also cause physical damage to health. I hereby affirm that I do not suffer from cardiovascular problems or vertebral damage. For the purpose of self-protection, I commit to the organizer to wear safety suits with at least single-layer fire protection fabric and helmet. I am aware that driver and organizer have concluded a comprehensive liability exclusion with the exception of bodily injury and deliberate or grossly negligent breach of duty on the part of the organizer.

I declare the renunciation of claims of any kind against the organizer and other participants for damages arising in connection with the event against:

- The organizer of the VLN VV GmbH & Co.KG, their vicarious agents and volunteers;
- The local clubs of the VLN Sport GmbH & Co.KG, their vicarious agents and volunteers;
- The road construction authority, insofar as damage is caused by the condition of the roads used at the event, including equipment, and
- the vicarious agents, the legal representatives, the executive bodies, the agents, the full-time and volunteer employees
  of all aforementioned persons and bodies as well as their members.

# Passenger/ Instructor

The waiver of liability shall not apply to damages resulting from injury to life, body or health. Furthermore, the waiver of liability shall not apply to any other damage resulting from an intentional or grossly negligent breach of duty, nor to any damage resulting from the breach of a material contractual obligation by the liable party. Material contractual obligations are to protect the legal positions of the contractual partner which are material to the contract and which the contract is intended to grant to the contractual partner in accordance with its content and purpose; material contractual obligations are also obligations the fulfillment of which makes the proper performance of the contract possible in the first place and on the observance of which the customer has regularly relied and may rely. In the case of damage caused by a slightly negligent breach of essential contractual obligations, liability for financial loss and damage to property shall be limited to the amount of typical, foreseeable damage. Insofar as the waiver of liability is not excluded in accordance with the above, the waiver of liability shall apply to claims based on any legal grounds, i.e. in particular to claims for damages based on contractual and non-contractual liability and to claims based on tort. A reversal of the burden of proof is not associated with this provision.

I commit to follow the instructions of the organizer, his agents or other helpers at all times. I further commit to visibly wear the wristband given by the organizer during the entire duration of the event and to present it upon request. I am aware that I, as well as the driver of the vehicle, can be excluded from the event and thus also from further rides if the wristband is removed.

I am aware that vehicles which are not approved for public road traffic may participate in the event. The participants commit to inform each other comprehensively about possible dangers of participation.
