Responsibility: Participants (drivers, passengers, if any) take part in the event at their own risk. They bear the soleresponsibility under civil and criminal law for any damage caused by them or by the vehicle they are using. The participant is aware that, pursuant to the authorities' operating permit for the Nürburgring, fines of at least 5,000€ may be imposed for repeated infringements of the noise level regulations. In specifically severe cases, the NG 27 may also order to stop the event. Driver and car owner are jointly liable for any such contractual penalties and for all the costs involved in a stopping of the event, if applicable. The organiser has not concluded a liability insurance for the participants as this is not an event to achieve maximum speeds. All participants are obliged to report an apparent accident to the NG 27 in the Race Control Tower or to the VLN VV!

Validity report:

These GTCs apply to all legal relationships between the competitor/team as well as driver and/or vehicle owner and the organizer, promoter, series organizer of the NLS, VLN Sport GmbH & Co. KG (hereinafter "VLN Sport"), the VLN VV GmbH & Co. KG (hereinafter "VLN VV"), their managing directors, bodies, agents, employees and members. These GTCs apply in particular to the entry and participation in an event/race of the Nürburgring Endurance Series (hereinafter "NLS") or its supporting program, at the Nürburgring, which are organized by the organizer VLN VV and the organizer VLN Sport.

I agree with the participation of my vehicle and my person (my vehicle as owner) in the aforementioned test and setting drive and confirm that I have taken full note of the entry.

I declare the renunciation of claims of any kind against the organizer and other participants for damages arising in connection with the event against:

- The organizer of the VLN VV GmbH & Co.KG, their vicarious agents and volunteers;
- The local clubs of the VLN Sport GmbH & Co.KG, their vicarious agents and volunteers;
- The road construction authority, insofar as damage is caused by the condition of the roads used at the event, including equipment, and
- the vicarious agents, the legal representatives, the executive bodies, the agents, the full-time and volunteer employees of all aforementioned persons and bodies as well as their members.

The waiver of liability shall not apply to damages resulting from injury to life, body or health. Furthermore, the waiver of liability shall not apply to any other damage resulting from an intentional or grossly negligent breach of duty, nor to any damage resulting from the breach of a material contractual obligation by the liable party. Material contractual obligations are to protect the legal positions of the contractual partner which are material to the contract and which the contract is intended to grant to the contractual partner in accordance with its content and purpose; material contractual obligations are also obligations the fulfillment of which makes the proper performance of the contract possible in the first place and on the observance of which the customer has regularly relied and may rely. In the case of damage caused by a slightly negligent breach of essential contractual obligations, liability for financial loss and damage to property shall be limited to the amount of typical, foreseeable damage. Insofar as the waiver of liability is not excluded in accordance with the above, the waiver of liability shall apply to claims based on any legal grounds, i.e. in particular to claims for damages based on contractual and non-contractual liability and to claims based on tort. A reversal of the burden of proof is not associated with this provision.

The organizer is entitled to control the compliance of all information and regulations of the entry and the waiver itself or by third parties. I am aware that I can be excluded from the event without reimbursement of the entry fee in the event of violations of the participation regulations, in particular if an unauthorized co-driver is transported or noise protection regulations are violated.

General contractual declarations of the driver:

The driver must accept facts in the person or the behavior of a team member (driver, mechanic, helper, etc.), which affect the contractual relationship with the organizer or justify a claim for damages, for and against himself. The driver is liable for all obligations arising from the entry contract as joint and several debtor. The driver assures that:

- the information given in the entry is correct and complete,
- the driver is able to meet the requirements of the event without any restrictions,
- the vehicle complies with the technical regulations in all points,
- he will use the vehicle only in technically and optically perfect condition at the respective event.
- he has taken note of the event announcement, - he/she accepts these as binding for him/herself and will comply with them,
- these rules and regulations and the declaration in this entry form become part of the contract with the organizer with his consent,

By signing this contract, the vehicle owner fully agrees to the use of the vehicle and any penalties imposed on it in the event of violations of the soundproofing conditions.

The waiver of liability applies to claims based on any legal grounds, in particular to claims for damages arising from both contractual and non-contractual liability and also to claims arising from tort. Tacit exclusions of liability shall remain unaffected by the above waiver. The exclusion of liability becomes effective for all participants with the submission of the entry. With the signature I agree that the given data according to the data protection basic regulation (DSGVO), which can be found on the homepage www.VLN.de/datenschutz, may be used by the organizer and/or organizer, according to the legal regulations.
